Release and Indemnity Agreement

Parent or legal guardian must sign for all participants under eighteen (18) years of age.

I state that I wish to participate -- or to have my minor dependent participate -- in activities offered by the Boeing Employees Everett Gun Club (hereinafter referred to as "EGC"), a Boeing Recreation Club.

I RECOGNIZE THAT ANY EGC ACTIVITIES MAY INVOLVE CERTAIN DANGERS. I certify that I am aware of all the obvious and inherent dangers of EGC activities, including but not limited to, misuse of firearms, malfunction of firearms or other equipment, improper handling of firearms, inexperience, accidents or illness in areas without medical facilities, and the actions of any other club members, any participants, or any other persons all of which may result in personal injury, death, property damage and other losses.

In consideration for the right to participate in EGC activities, I hereby release the EGC and its instructors and members, and the Boeing company, from any and all liability, claims and causes of action arising out of or in any way connected with my -- or my minor dependent's -- participation in any EGC activities. I personally assume all risks in connection with these activities, and I further agree to indemnify the EGC and its instructors and members, and the Boeing company, from all liability, claims and causes of action which may have arising from my participation -- or my minor dependent's participation -- in EGC activities. The terms of this agreement will serve as a release and indemnity agreement for my heirs, personal representative, and for all members of my family, including any minors.

I further state that I am eighteen (18) years of age or older and legally competent to sign this release that I understand these terms are contractual and not a mere recital, and that I have signed this document as my own free act.

In signing this document, I also certify that I am not in violation of local, state and federal laws regarding the use and possession of firearms.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS RELEASE AND INDEMNITY BY READING IT BEFORE I SIGNED IT.
